

We traded problems. He took for me a homeless Vet whose dad had just died. Rich drive him around to help him access some money he inherited, and then the Vet bought a vehicle. We might buy Rich a thank you tank of gas.

I took over his problem, dealing with a highly decorated Air Force retiree, who has been rescued by friends after suffering elder financial abuse by his daughter. Oriented his helpers to VA healthcare enrollment and eligibility, state Veterans homes, and county Dept. of VA.

Rich also spearheaded getting another homeless Veteran a car. MFSG provided the funds. Only Kindness will use funds held for my discretionary use to pay for getting the Vet his insurance.

Referred Rich to Senior Legal at the county on another Veteran facing eviction issues.

I seem to be the new EDVR transportation coordinator, as Tim Page is trying to step back. Not doing as well as Tim, but did put together a ten strong team to help a Veteran with his regular dialysis treatments.

That same Veteran was supposed to get a new prosthetic leg, but the VA is so screwed up, presumably by COVID, that they never issued the purchase order, and the appointment has been canceled until the VA wakes up, and does what they have promised to do.

Authorizing some fire safe work on an elderly Veteran's home.

Sure there is more, but just gives you a sense that even with hunkering down, there is work to do, and work getting done.

11 things you need to know about the LEGION Act

With President Trump's **signature on the LEGION Act**, the extension of the ongoing declared period of war was extended back to Dec. 7, 1941. The congressionally approved act is a way to honor thousands of veterans who were killed or wounded on duty during periods not previously considered a time of war.

"Finally Congress has acknowledged the service and sacrifice of at least 1,600 veterans who died or were wounded in previously undeclared periods of war," said American Legion National Judge Advocate Kevin Bartlett. "This new law honors the memories of those veterans while allowing other veterans from those previously undeclared eras to receive all the American Legion benefits they have earned through their service." The LEGION Act - Let Everyone Get Involved in Opportunities for National Service Act — also redefines The American Legion's membership eligibility dates. The eligibility now span from Dec. 7, 1941, until a time when the U.S. is no longer at war, as determined by Congress.

Here are answers to 11 key questions about the new law and what it means for The American Legion.

Question: How does this change the eligibility requirements for The American Legion?

Answer: The only change is that Congress has reduced the number of eligibility periods from seven to two. They are April 6, 1917, to Nov. 11, 1918, and Dec. 7, 1941, and continuing. No other restrictions are changed.

Question: What's the impact on veterans who previously were not eligible for American Legion membership?

Answer: Veterans who were honorably discharged but whose service did not fall into the previous defined war eras may now join The American Legion immediately. To do so, eligible members may sign up at www.legion.org/join.

Question: I am among the veterans who were not allowed to join previously, so why do you want me now?

Answer: The American Legion's founding fathers believed, "a veteran is a veteran," an axiom that has held true throughout the organization's more than century of service. Some veterans were ineligible to join because of the war eras that were defined by Congress. The recent bill passage and president's signature changed that.

Tax exemptions for Veterans

There are two categories for full property tax exemptions in California. Eligible veterans or their surviving spouse may receive a basic exemption if the assessed value does not exceed \$100,000; or a low income exemption if the assessed value does not exceed \$150,000 when the household income does not exceed \$40,000. Both categories are for full property tax exemptions.

The Disabled Veterans' Exemption reduces the property tax liability on the principal place of residence of qualified veterans who, due to a service-connected injury or disease, have been rated 100% disabled or are being compensated at the 100% rate due to unemployability. An unmarried surviving spouse of a qualified veteran may also claim the exemption. There are two levels of the Disabled Veterans' Exemption:

Basic – The basic exemption, also referred to as the \$100,000 exemption, is available to all qualifying claimants. The exemption amount is compounded annually by an inflation factor. For example, for 2018, the basic exemption amount was \$134,706.

Low-Income – The low-income exemption, also referred to as the \$150,000 exemption, is available to qualifying claimants whose annual household income does not exceed a specified income limit. The amounts for both the low-income exemption and the annual income limit are compounded annually by an inflation factor. For example, for 2018, the low-income exemption amount was \$202,060 and the annual household income limit was \$60,490.

This Disabled Veterans' Exemption is a more advantageous exemption than both the Veterans' Exemption and the Homeowners' Exemption. Thus, if a claimant qualifies, the Disabled Veterans' Exemption should be claimed on the property instead of either of those two exemptions.

10 Veterans Benefits You May Not Know About

Many veterans know about the basic health care and education benefits available to them through the Department of Veterans Affairs: Tricare and the GI Bill.--- While these benefits alone are substantial, numerous other programs help provide more benefits to veterans and their families. Even within the health care and education programs are little-known benefits to improve the lives of veterans and help ease the financial burden of medical care or other expenses. Here are 10 veterans benefits you haven't heard about that all veterans should see if they qualify for.

Long-term Care

Long-term care is expensive, but often necessary to provide care for aging relatives. Through the Aid and Attendance program, many veterans are eligible to receive money to cover the cost of nursing homes, assisted living programs and other long-term care options. With the ability for couples to receive up to \$25,020 a year, the Aid & Attendance benefit will help take care of a significant portion of long-term care costs. Surviving spouses of veterans are also eligible to receive up to \$13,560 a year to cover their long-term care costs.

Caregiver Support

Should you choose to take care of an ailing Veteran at home, the Department of Veterans Affairs offers a caregiver support program. While this program does not offer any monetary support to caregivers, they are provided with a free support line and a caregiver support coordinator to help navigate military benefits and the stress of care giving.

Death Benefits

When a veteran dies, families have a few unique benefits available to them. A U.S. flag may be requested to drape over the casket and families may request a Presidential Memorial Certificate to honor the deceased loved ones service. The Department of Veterans Affairs also provides free headstones or grave markers.

Non-College Degree Programs/Certificates

In addition to receiving credits to use towards a college degree, the GI Bill is available for training certification courses or other vocational training programs such as HVAC repair, truck driving, emergency medical training, and barber/beautician school. This benefit will work well for veterans who wish to change careers or pursue a career path that does not require a college degree. Other non-college degree programs are available through the VET TEC program which offers "accelerated training in coding bootcamps" or similar information science programs, software training, etc. Lastly, there are several free it certifications available to veterans.

Transferring GI Bill® Credits

Unused credits through the GI Bill may be transferred to spouses and dependents of veterans. There are service limits required to transfer the benefits.

Free Tax Preparation

Veterans and their family have access to free tax preparation services through the Volunteer Income Tax Assistance offices on military bases. The individuals who work in the offices have expertise working with the complicated nature of military-related tax issues.

Life Insurance

Many veterans have trouble obtaining traditional life insurance, particularly if they sustained an injury during their time of service. Through the Service members' and Veterans' Group Life Insurance program, veterans may receive up to \$400,000 in life insurance. This program also offers competitive premium rates.

Mortgage Help

Veterans having trouble making their mortgage payments are eligible for repayment assistance through the Department of Veterans Affairs. Options for help include special repayment plans, loan forbearance and loan modification programs. Additional benefits are available for veterans with VA loans and for homeless veterans.

VA Foreclosures

The VA maintains a list of homes serviced by VA loans that have gone into foreclosures. Veterans have the ability to search the list of VA acquired properties and purchase homes at a discount. You do not have to be a veteran to search the properties, but all properties qualify for VA financing.

American Corporate Partners

American Corporate Partners connects veterans with top companies to help them obtain a job after their time of service. Along with being connected to job opportunities, veterans have the opportunity to receive one-on-one mentoring and other career development services.
